

## Formulation restrictions - Black List

# List and groups of substances banned by TPD

- Vitamins or other additives with beneficial effects or with reduced health risks (Vitamins C, fatty acids Omega-3)
- Caffeine, taurine or other additives (theine or guaranà) e stimulants substances associated with greater energy and vitality
- Additives that have emissions coloring properties
- Additives with carcinogenic, mutagenic and reproductive toxic (CMR) properties
- Except for nicotine, the ingredients used in the e-liquids should not contain risks to human health in heated and unheated forms

The countries Germany, United Kingdom, Hungary and Netherlands, in addition to TPD prohibitions, published a list country-specific of prohibited substances and groups of substances.

### OTHER COUNTRY-SPECIFIC PROHIBITIONS

FINLAND [FI]: complete ban of flavors except tobacco flavors.

**ESTONIA** [**ES**]: starting from 1 July 2019 it's prohibited the sale of flavors products other than tobacco ones.

**DENMARK** [**DK**]: complete ban of flavors excluding tobacco and menthol.

LATVIA [LV]: complete ban of flavors excluding tobacco.

**LITHUANIA** [LT]: complete ban of flavors excluding tobacco.

**SLOVENIA** [SI]: it is in discussion a new law proposal to introduce a complete flavor ban.
